



STEP 1: Remove electrical power from the ceiling box before beginning installation steps. Ensure oil electricity is turned off.

OPTIONAL: You may choose to install mounting screws into the junction box at this time. Do not drive the screws completely into the junction box. Alternatively, you can choose to wait until after the disc is wired.

## STEP 2:

Remove the lens from the disc.



#### STEP 3

Connect the supply wires to the junction box using the provided wire nuts (black to black, white to white and green/ground to ground).



### STEP 4:

If you already have the screw mounted to the junction box. line up the screw holes on the disc light and attach by turning the fixture clockwise. Otherwise, lining up the screw holes on the junction box and disc light, insert the screws, screwing it in a few threads and turn clockwise. Tighten the screws to secure fixture in place.



## STEP 5:

Finally, twist the lens back onto the disc to complete installation.



#### STEP 6

Restore electrical power to the ceiling box and enjoy your new light.
