

LED TUBE INSTALLATION GUIDE – WARNING

NOTE:

- This lamp might not be compatible with all dimmers. Please visit www.greencreative.com for compatibility information.
- Operates on electronic ballasts only.
- This lamp is not compatible with luminaires that use a remote starter.
- Suitable to replace T8 fluorescent lamps as specified on the product label.

INSTALLATION INSTRUCTIONS:

1. Switch-off power to luminaire.
2. Remove diffuser (if provided).
3. Remove existing fluorescent lamp(s) from luminaire. Note: Verify that the fluorescent tube type is listed on the LED lamp label.
4. Install LED lamp (one for each fluorescent lamp removed, ensure pins are firmly seated in lampholders).
5. Switch on power to luminaire and reattach diffuser (if provided).

If a Product fails to conform with this limited Warranty for the specified period below, Seller will at its sole option, either (i) repair the Product at no charge, or (ii) replace the Product at no charge or (iii) provide Buyer a credit for a future Product purchase calculated as follows: (Invoice price of the Product (\$) x undelivered Warranty period (operating hours)) / intended Warranty period (operating hours)

Replacement of the Product does not include any removal or reinstallation costs or expenses, including without limitation labor cost or expenses, shipping costs to return non-conforming Products or any damage that may occur during the return of the Product to the Seller. If Seller chooses to replace the Product and is not able to do so because such Product has been discontinued or is not available, Seller may replace it with a product of comparable functionality.

Replacement Product or parts provided under the terms of this warranty are warranted for the remainder of the warranty period of the original Product or original parts they replace.
